A cat's name, including cattery names and the word "of" (before a suffix) may not exceed 35 characters (including spaces). If the name of the cat is longer than 35 characters, the suffix will be automatically dropped (if applicable). The name of the cat must not contain any special characters (&, ', #, ö, é, etc.). The owner's name, address, and city are not allowed in the name of the cat unless they are part of a TICA registered cattery. For additional restrictions, please refer to Registration Rules 39.5, 39.6, 39.7, and 39.8.

If you are registering the cat with a pedigree from another association and the cattery names of those associations are not registered to the same owners in TICA, the name will be cut off after 32 characters and /xx will be added at the end. "xx" is a placeholder to indicate the name of the originating association, e.g. /CF for CFA, /GC for GCCF, or /ID for an "independent" association. If you are using the form on page 4 and the breeder of the cat has a TICA registered cattery name, this cattery name will be used and no "/xx" will be added. If you have a TICA registered cattery but you are not the breeder, you can add your cattery name as a suffix if there is enough space available.

### Registration Information

You may register any pedigreed cat with TICA if you can provide the documents necessary for one of the following scenarios:

- You have a TICA Breeder Slip.** A TICA Breeder Slip is issued for each kitten when a litter is registered with TICA. In this case **you do not need to use this form**. Fill out the TICA Breeder Slip and send it to the Executive Office or register your cat at <http://online.tica.org>.
- You have a certified pedigree from an approved registry.** The pedigree contains at least 3 generations. For each ancestor the pedigree must show the name of the cat, the registration number, the color, and the pattern. You must also provide proof of ownership (e.g. registration certificate from that registry). In this case **you do not need to use this form**. For further instructions, please refer to <http://tica.org/faq/step-by-step/item/1008>.
- You have a pedigree signed by the breeder of the cat.** The pedigree must contain at least 3 generations. For each ancestor the pedigree must show the name of the cat, the registration number, the color, and the pattern. All of the information must be in English and use TICA's terminology (see <http://tica.org/pdf/publications/ucd.pdf>). For color, pattern, and eye color you can also use EMS codes. If any of the ancestors are already registered with TICA and the TICA registration number is provided, the ancestors of that cat do not have to be listed. The pedigree must contain the following statement in English "I certify this pedigree to be true and correct". The breeder's signature must be directly next to this statement. The breeder is defined as the owner of the dam at the time of mating. We suggest you use the form on page 4 of this application for this scenario. You must also provide proof of ownership (e.g. registration certificate from another association, transfer report, sales contract).









After the registration has been processed, the names of cats may only be changed as outlined in Registration Rule 39.4.

Under extenuating circumstances (e.g. death, repossession), proof of ownership might be established using different documentation. Please contact the Executive Office in such cases to find a solution.
